Introduction

The Nuclear Institute (NI) is dedicated wholly and exclusively to nuclear covering every aspect, from new build to operations to waste management and decommissioning. We also cater for those working in defence, medical and safety options.

Our charitable objectives include advancing the education of nuclear energy, science, engineering, and technology, and increasing the public understanding of nuclear sciences and the impact on society and the environment.

Establishing the Company Membership Scheme with the NI provides tangible benefits, as follows:

- Provides independent verification of the nuclear professionalism of employees accepted as full Members and Fellows of the NI.

- Delivers a tangible employment benefit to attract and retain essential talent.

Helps establish and maintain high standards across the organisation

- Maintains and reinforces consistent high standards of nuclear professional practice across the organization.
- Maintains currency of industry knowledge across the team.
- Strengthens the professional networks for employees at all levels of the business.
- Provides access to current thinking and emerging practice via special interest groups, industry updates and events.

Supports formal employees development structures and arrangements

- Training and regular updating provided by the NI ensures that membership assessors can support career progression at the appropriate level.
- NI Programme Approval (optional) helps ensure company training and professional development programmes align with the Nuclear Delta®.
- Facilitates support and assessment for employees applying for professional membership of the NI.

Terms and Conditions of Company Membership

When you agree to become a Company Member of the NI, you will need to confirm acceptance of our Terms and Conditions.

Breach of the Terms and Conditions may lead to the withdrawal or suspension of your Company Member status.

The NI is the Data Controller of any personal data you supply, and any subsequent interaction as a member of the NI or Representative for your Company Membership. Your data will be managed in accordance with the NI's Privacy Policy.

- Company Membership of the Nuclear Institute runs from January to December each year and is a rolling agreement which will be renewed automatically on 1 January each year.
- The NI reserves the right to increase or vary the price of membership on an annual basis. Fees for the coming year will be published on the NI website in October each year.
- Your Company Membership may lapse if relevant fees remain unpaid more than 3 months after the due date.
- Annual subscription fees are non-refundable.
- The NI reserves the right to vary the benefits of the Company Membership Scheme from time to time.
- Membership benefits and updates are communicated through the key contact(s), and it will be their responsibility to disseminate this information to other members of staff and promote membership of the NI.
- It will also be the responsibility of the key contact(s) to inform the NI of any update of information pertinent to the company.
- The NI will not be liable for the non-delivery of communications, products, and services if you have supplied us with an incorrect postal or email address, have not notified us of a change with the key contact(s), or have not appointed new one(s) following a change in your staff team.
- You may cancel your Company Membership of the NI at any time by notifying us in writing by email.
- The NI reserves the right to withdraw or suspend your membership if you are found to be in breach of the Terms and Conditions and in particular if you;
 - have failed to pay fees within a reasonable period of time.
 - have misrepresented your Company Member status.
 - have falsely implied NI endorsement of products, services, policies, and activities of your Company.

Features of the Scheme

Streamline your membership with a regular service review

- Evidence requirements to meet the Nuclear Delta®; identifying appropriate evidence from the employee's own role and work activities.

Tailor industry events and functions to your business' needs

Do you have a great idea for an event? Let us know! Our regular check-up also means we get to hear about the needs you see in the nuclear sector, so we can better target our offering based on observations from the coalface of the industry.

Nuclear Institute events are tailored to industry-specific trends and are organised at both a branch and central level. This means your team are kept constantly up-to-date with industry best-practice from top professionals in their field.

Nuclear Institute Lunch & Learn Sessions for Company Membership Schemes

What does an NI Lunch & Learn session cover?

The aim is to introduce the NI and explain the ways that your employees can get involved. Normally the session lasts 1.5 to 2 hours and will introduce the Nuclear Institute, membership, and progression opportunities to your employees.

Typically, each session is broken down into three themes:

- About the NI.
- Membership, professional registration, and recognition.
- Getting involved: Branches, YGN, NI Events, SIGs, volunteering opportunities.

We can vary the emphasis in line with your aims and priorities. For example, some organisations wish to focus on assessment for professional membership of the NI and professional registration; others wish to emphasise *Getting Involved* as a route to closer engagement with the NI's professional community.

Who is involved?

We use the sessions to enthuse and encourage your employees to get involved, to *'get out what they put in'* and to consider how involvement with the NI and the YGN network can help them in their careers.

We invite NI members to talk about their experiences of volunteering with the NI, including:

- Why they got involved.
- The benefits and challenges of volunteering alongside 'the day job'.
- How their NI activity is helping them in their careers.

If applicable, we will invite an experienced NI Membership Assessor to explain the assessment process and requirements for NI membership and professional registration with the Engineering Council, Science Council, or the Society for the Environment.

Employees often find an informal discussion with a Membership Assessor to be very useful. The opportunity to ask questions relating to their own job role or career, and how they generate appropriate evidence for assessment can help to overcome perceived barriers that would otherwise go unnoticed and unresolved.

Ideally a Senior Management Representative will attend or introduce the session to reinforce your organisation's support for the Company Membership Scheme.

Outcomes

Your employees will have the information plus contacts to engage with the local Branch and YGN networks. We will schedule a follow up discussion with you to agree next steps, particularly in relation to supporting professional membership applications.

Annex 1 - The Nuclear Institute and Member Benefits

Additionally, in line with our charitable objectives we promote understanding of the nuclear industry by the wider public.

As a charitable status organisation, the Nuclear Institute has a thriving volunteer community of nuclear professionals organised through our Regional Branch structure and the Young Generation Network (YGN).

Special Interest Groups (SIGs) are formed in response to member interest and current/emerging issues within the sector. The NI works with individual and Company members to develop and promote SIGs where they can provide an appropriate vehicle for knowledge sharing and professional development.
